PRODUCT DESCRIPTION

All-purpose liquid sanitizer that can be used on equipment, ceilings, floors, walls and utensils.

Destroys malodors.

No water rinse is required if solution does not exceed 400 ppm of active ingredient.

Biodegradable and phosphate-free formulation for a better environmental choice.

Has a residual effect to better protect treated surfaces.

Good compatibility with hard water and high organic loads.

Recommended for organic production under CAN/CGSB-32.311 and 310.

DILUTION: Prepare a quaternary solution containing between 100 and 1000 ppm of active ingredient (1 to 10 mL/liter of water). Use potable water between 5 and 65°C.

APPLICATION: Ensure that all surfaces are clean before the treatment. Apply the solution by spraying or soaking. Wet surfaces sufficiently to provide at least 1 minute of contact time. Allow excess solution to drain off. Prepare a fresh solution for each use.


METHOD:

Regular sanitation:

Spraying or soaking: Use 150 to 400 ppm without rinsing (1.5 to 4 mL/liter of water).

Other applications:

Shock treatment, misting, door sills and soaking basins: Use 400 to 1000 ppm (4 to 10 mL/liter of water).



